

# What is Kinship Care?

Kinship Care is the "full-time care and nurturing of a child by a relative or someone with a significant emotional connection to the child, such as a close family friend, when parents are not able to provide care."

~Children's Bureau, Bulletin for Professionals June 2018





### Fact about Kinship Care\*

32% of placements of foster care children are with relatives (kinship care)

North Carolina data shows similar percentage as the national data

#### Older Adults as Kinship Caregivers

Of the 32% of children living with relatives, 37% of these children are being raised by relatives ages 60 and older without their parents present

Facts about Older Adults and Mental Health 5.7 million adults aged 65 and older who binge drink in the past month, or the 1.5 million adults aged 65 and older who used an illicit drug in the past month according to SAMHSA's 2017 National Survey on Drug Use and Health

Suicide is the eighth leading cause among people 55 to 64 years of age according to the Center for Disease Control's 2020 Fast Fact Sheet

- Need for Updated Data on Older Adults as Kinship Caregivers
- Screening for Mental Health problems at doctor appointments
- Research on best practices for counseling these kinship care families
- Survey participants of Medicare coverage Part B for mental health services
